The need for rheumatologists in the Republic of Kazakhstan at all levels of medical care is very high.

The need of medical organizations for rheumatologists is the justification for the discovery and the need to train rheumatologists, primarily at the regional level, taking into account the main strategies and programs for the development of the healthcare system at the international, national and regional levels in order to increase the level of rational use of medicines.
